What does the fund invest in?

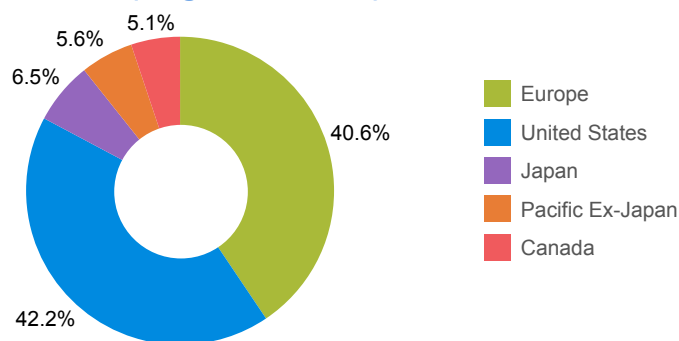
The fund follows a sustainable thematic approach and invests in common shares of small, medium and large-cap global companies. The fund integrates broad environmental, social and governance criteria, and excludes all issuers directly involved in the extraction, processing and transportation of fossil fuels. The fund seeks to help improve the world by investing in companies offering leading environmental and social solutions.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Genus Capital Management Inc. has rated the volatility of this fund as **Medium**. This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

How has the fund performed?

Who is this fund for?

This fund may be suitable for investors who:

- you are not willing to accept some fluctuation in the value of your investment

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

If you hold this fund in a non-registered account, fund distributions are included in your taxable income, whether you receive them in cash or have them reinvested.

How much does it cost?

The following sections show the fees and expenses you could pay to buy, own and sell Series F units of the fund. The fees and expenses - including any commissions - can vary among series of the fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

There are no sales charges or other commissions associated with the purchase of Series F units of the fund. However, your representative may charge you ongoing advisory fees in the account. Advisory fees are negotiable between you and your representative.

2. Fund expenses

Fees and expenses are charged to the fund and reduce your returns. The fund's expenses for Series F units are made up of the management fee, operating expenses and trading costs. The series' annual management fee is 0.65% of the series' value. Because this series of the fund has not yet been sold under a simplified prospectus for 12 consecutive months, its operating expenses and trading costs are not yet available.

More about the trailing commission

No trailing commission is paid in respect of Series F units.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
Short-term trading fee	Genus Capital Management Inc. has the discretion to charge you up to 2% of the value of your units if you switch or redeem your units within 30 days of buying units of the fund. This fee will be paid to the fund.
Registered tax plan fees	Your dealer may charge you a fee. These charges are negotiated between you and your dealer.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or

- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
